NOMINATION CRITERIA | 提名标准

Nomination Method 提名方式

Open to professionals, industry peers, and organizations; candidates may self-nominate or be nominated by others.

Must be 35 years old and above.

Must hold an executive position such as Founder, CEO, or General Manager.

Achievements 业务成就

Must demonstrate excellence in innovation, leadership, industry contributions, and corporate social responsibility.
必须在创新、领导力、行业贡献及企业社会责任方面表现卓越。

NOMINATION PROCESS | 提名过程

1. Fill Out the Google Form 填写提名表单

- Nominees must complete the official Golden Empress Award 2025 Google Form.
- Provide accurate personal and professional details, and select the appropriate award category.
- 提名人需填写官方《金凰奖 2025》Google 提名表单。
- 提供准确的个人与职业信息，并选择合适的奖项类别。

2. Submit Supporting Documents 提交相关资料

- Upload necessary attachments, such as business achievements, certifications, and testimonials.
- 提交所需附件，如商业成就、认证证书及推荐信等。

3. Review & Evaluation 评审审核

- The organizing committee will review all submissions to ensure compliance with award criteria.
- Only qualified nominees will proceed to the next round of evaluation.

4. Winner Announcement 颁奖者通知

- Winners will be notified via email and phone once the final selection is made.

TERMS AND CONDITIONS | 条款和条件

1. Eligibility & Nomination Rules 参选资格与提名规则

- Open to female entrepreneurs aged 35 and above holding executive positions (e.g., Founder, CEO, General Manager).
- Nominees must have outstanding achievements in their fields and demonstrate leadership, innovation, and industry contributions.
- All submitted information must be accurate and verifiable. Any false or misleading information will lead to immediate disqualification.
- Nominations must be submitted via the official Google Form before the deadline. Late or incomplete submissions will not be accepted.
- 适用于 35 岁及以上的女性企业家，需担任企业高管职位（创始人、CEO、总经理等）。
- 须在行业内取得卓越成就，并展现领导力、创新力及行业贡献。
- 所有提交信息须真实且可验证，任何虚假或误导信息将导致取消资格。
- 提名须通过官方 Google 表单提交，逾期或不完整的提名将不被受理。

2. Submission & Documentation 资料提交

- Submissions must include a detailed portfolio, business certifications, and supporting documents.
- All submitted materials must be original. Any plagiarism or intellectual property infringement will result in disqualification.
- MIVA reserves the right to request additional documentation for verification.
- Privacy & Data Protection: All submitted materials will be used solely for evaluation and event promotion. MIVA ensures confidentiality and will not share personal data with third parties without prior consent.

3. Judging & Selection 评审与评选

- Nominations will be reviewed by an independent panel of judges appointed by MIVA.
- Judging decisions are final and cannot be appealed.
- MIVA reserves the right to modify or cancel award categories if there are insufficient qualified nominees.

4. Disqualification & Withdrawal 取消资格与撤回

- Any nominee violating the terms will be immediately disqualified.
- Nominees may withdraw their submission by notifying MIVA in writing before the deadline.
- If post-event misconduct is discovered, MIVA reserves the right to revoke the award and request its return. MIVA may also publish an official statement regarding the revocation.
